  - d. The **DR. VRK WOMEN'S COLLEGE OF ENGINEERING AND TECHNOLOGY** Academic Centre will have the right to collect fees from the students towards:
    - Registration
    - Course/ Skill conduct
    - Evaluation of the Academic/ Skill portion of each Level of the Programme, A portion of the fees as agreed upon by the **DR. VRK WOMEN'S COLLEGE OF ENGINEERING AND TECHNOLOGY** Academic centre and the **RAM INNOVATIVE INFOTECH** shall be turned over to the **RAM INNOVATIVE INFOTECH**.

- k. The **DR. VRK WOMEN'S COLLEGE OF ENGINEERING AND TECHNOLOGY** Academic Center shall submit details of students registered, evaluation conducted and results to the Technical Board or the University, as the case may be, and also upload the same on AICTE Web-Portal.

**4. General:**

**Fees to be charged to students:**
