In case of students of the college, she will be expelled from examination halls and cancellation of their performance in that subject and all other subjects the candidate(s) has already appeared and shall not be permitted to appear for the remaining examinations of the subjects of that semester/year. The candidate is also debarred and forfeits their seats. The candidate who do not belong(s) to the college, they will be handed over to the police and a police case is to be registered against them.	
10.	Copying detected on the basis of internal evidence such as during valuation or special scrutiny	Cancellation of the performance in that subject and all other subjects the candidate has appeared including practical examinations and project work of that semester/year examinations.	
11.	If any malpractice is detected which is not covered in the above clauses from 1 to 9 shall be reported to the head of the institution for further action on suitable punishment
