ANTI-RAGGING COMMITTEE

It is the duty of the Anti-Ragging Committee to ensure compliance with the provisions of the Regulations as well as the provisions of current law in force regarding ragging and to monitor the Anti-Ragging Squad prevent ragging in the institution.

It shall be the obligation of the Anti-Ragging Squad to call upon, to make surprise raids to vulnerable and potential areas of ragging and has the authority to inspect such places. It shall also be the duty of the Anti-Ragging Squad to conduct an on-the-spot enquiry of any incident of ragging referred to it by the Head of the institution or any member of the faculty or any member of the staff or any student or any parent or guardian or any employee of a service provider or by any other person, as the case may be and the report of the enquiry along with recommendations shall be submitted to the Anti-Ragging Committee for the required action to be taken. The Anti-Ragging Squad shall conduct enquiry through fair and transparent procedure and follow the principles of justice and gives adequate opportunity to the accused students who has done ragging and other witnesses to present the facts, documents and views the incidents of ragging, and considerations other relevant and required information.
