Minutes of the Meeting

The first IQAC meeting of DRVRKWCET for the academic year 2018-2019 was held on 19/07/2018 at 11:30 am in Principal's Ccabin.

Dr. Prasana Kumar, Member IQAC, welcomed all the members of the IQAC. The meeting started with a permission of the Head of the Institution.

1. Review of last meeting minutes

The last meeting minutes were reviewed and the status of the same was discussed.

2. Review of Academic Audit report for 2017-2018 Second Semester

Dr. Aleemuddin Ghouri, who is a member of the Internal Quality Assurance Cell (IQAC) and also serves as the coordinator for the academic audit of the second semester of 2017-18, presented the audit report encompassing all departments audited in July 2017, thereby initiating the ensuing discussion. During the deliberations, members proposed the inclusion of CO-PO (Course Outcomes-Program Outcomes) attainment calculation and the consideration of departmental strength in the audit process. The Head of the institution, Dr. B. Sasi Kumar, granted approval for the suggested enhancements to be incorporated starting from the subsequent audit cycles.

3. Review of Results of University Examination APR / MAY 2018

The individual in charge of the Examination Branch, Mrs. Shaheena Kamrani, provided a presentation on the outcomes of the university examination conducted in the month of APR/MAY 2018. In response, committee members put forth several ideas aimed at enhancing the pass percentage. These suggestions included the adoption of new methods and strategies, as well as the implementation of motivational initiatives for the students.

4. Review of Feedback of Students, Faculty, Alumni and Employers and Action Taken

The members were presented with an analysis report on the feedback obtained from students, faculty, alumni, and employers. The report included details about the actions taken in response

to the feedback received from these stakeholders. The efforts made by the institution to implement the suggestions provided by stakeholders for the enhancement of the teaching-learning process, measurement of learning outcomes, and improvement of operational structures and methodologies were acknowledged and appreciated by the members of the Internal Quality Assurance Cell (IQAC).

5. Review of effectiveness of Student Counselling

The institution has shown a strong commitment to implementing a mentor-mentee scheme. The counselling format for students utilized in previous years was showcased to the members. Upon review, members recommended the inclusion of a psychiatrist within the group of counselors to address the psychological issues faced by students. This addition aims to provide appropriate guidance to students, helping them overcome challenges and avoid distractions from their studies.

6. STTP on Women Empowerment

The institution has scheduled a three-day Short Term Training Programme on Women Empowerment for all students in September 2018. The primary objective of the program is to motivate students to establish their own companies and foster entrepreneurial skills among them.

7. Review of curriculum planning, course outcome and program outcome attainment

The Coordinator of the IQAC submitted a comprehensive report on curriculum planning and implementation, the measurement of course and program outcome attainment, and the department's endeavor and methodologies. The report outlined the department's substantial contributions to institutionalizing quality assurance strategies and processes.

8. Plan for orientation day of first year students

A request was made to the Head of the Department to formulate a plan for orienting newly enrolled first-year students. The objective is to facilitate the transition of their mindset from the school level to the college level.
