MINUTES OF THE MEETING

The first IQAC meeting of DRVRKWCET for the academic year 2020-2021 was held on 21.12.20 at 11.30 AM through Zoom Video Conference.

Mr. M.A. Lateef, IQAC, welcomed all the members of the IQAC. The meeting started with a permission of the Head of the Institution.

1. Review of last meeting minutes

The last meeting minutes were reviewed and the status of the same was discussed.

2. Review of Academic Audit report for 2019-2020 Second Semester

Dr. Aleemuddin Ghouri, Member IQAC and Coordinator of 2019-2020 second semester academic audit coordinator presented audit report of all departments conducted during October 2020 and initiated the discussion.

3. Review of Report on Feedback analysis and action taken

In September 2020, feedback from students, alumni, faculty, and employers was gathered and analyzed. The resulting report was presented to the members. The input, suggestions, and comments from stakeholders were carefully considered, and the principal assured the IQAC members that efforts had been made to implement the received suggestions. Additionally, the principal informed the members about a proposal submitted to the management for approval, outlining plans for the establishment of ICT facilities, smart classrooms, and additional computing resources.

4. UGC 2(f) Certification

The institution has set in motion a quality initiative to pursue NAAC accreditation. The initial phase involves applying for UGC 2(f) certification. To streamline this process, a committee, led by the IQAC coordinator and comprising senior faculty members, has been formed. The committee has been tasked with completing the necessary work within a six-month timeframe.

5. Registration of NSS unit with university

Since 2015, the institution has operated an NSS unit, organizing diverse programs such as Blood Donation Camps, Tree Plantations, Mass Cleaning, Yoga sessions, and more. The NSS unit has been actively engaged in community service, collaborating with individuals involved in social services. The extension activities conducted by the institute through NSS have received positive feedback from all members. In response, the members have urged the Principal to take necessary measures to register the unit with JNTUH, aiming to secure funds for furthering their extension services.

6. ISO 9001: 2015 Certification

The institution is encouraged to pursue quality assurance initiatives through accreditation with national or international agencies. Members have recommended that the IQAC proactively seek ISO certification. In response, the principal has urged the IQAC to establish a committee tasked with drafting the ISO Document and applying for accreditation within a time frame of 6 months.

7. Participation in NIRF

The institution's foundation lies in the high quality of teaching, learning, and infrastructure, establishing a robust basis. To be bench marked against leading institutes, participation in evaluation processes like NIRF is essential. Members have recommended the institution's involvement in NIRF ranking and have instructed the IQAC to form a committee dedicated to compiling and submitting the necessary data.

8. Faculty participation in FDP/Conference/Workshop/IPR/book publication

The involvement of faculty in FDPs, conferences, workshops, IPR, and book publications is under review. Members have recommended enhancing participation in these activities and have advised the principal to increase funding to support attendance.

9. Purchase of Books / Journals for Library

The librarian highlighted the need for books and journals aligned with the recently updated syllabus of JNTUH. In response, members instructed the principal to promptly take the necessary steps to release funds for the procurement of these books before the commencement of classes.

10. Faculty development program on OBE and Blooms Taxonomy based question paper The significance of implementing the OBE model and employing Blooms taxonomy-based question papers for enhancing teaching, learning, and outcomes was emphasized by the members. They instructed the IQAC to initiate a FDP focused on OBE and the creation of question papers based on Blooms taxonomy. This initiative is expected to be particularly beneficial for newly joined faculty members at the institution.
